Invitation for Bids for Procurement of Fabricated Steel Parts for Trail Bridges

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Ruby valley Rural Municipality for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The **Ruby valley** Rural Municipality invites online bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by www.nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information at the office of **Ruby valley** Rural Municipality and inspect the bidding documents in www.bolpatra.gov.np
5. Bidding documents may be downloaded from the office of **Ruby valley** Rural Municipality, Dhading or **www.bolpatra.gov.np** by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) **30 days** from the first date of publication of this notice.
6. Bids must be submitted online to the office of **Ruby valley** Rural Municipality, Sertung, Dhading or through www.bolpatra.gov.np, on date and time mentioned in table below. Documents received after this deadline shall not be accepted.
7. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, which shall be **valid for 30 days** beyond the bid validity period.
8. If bidder wishes to submit the Bid Security in the form of cash bidder has to deposit cash in first Account Number mentioned below. Bidder also must deposit Bid document fee in Second Account Number below.
